

### **TERMS OF USE**

### Use of the ZAINOO travel guide

Use of this website is governed by the terms and conditions described below. Your use of this website indicates your acceptance of these terms and conditions. ZAINOO with its main domain zainoo.com is operated by ALEWA – WebText, WebMarketing, WebConsulting OG (hereinafter referred to as: "ALEWA"). ZAINOO reserves the right to make modifications to these Terms & Conditions of Use at any time and without notice to users. You accept the obligation to review these Terms & Conditions of Use prior to each use, and your use of this website constitutes an acceptance to be bound by any modifications. These Terms and Conditions of Use are referred to hereafter as the "Agreement".

For the use of ZAINOO you have to activate a check box during the registration process. If you click this box, you expressly agree to the following terms and conditions. If you do not wish to be bound by these Terms, you may not use the site and its services! A violation of the conditions formulated here, entitles ZAINOO to an immediate exclusion from the use of this website and services.
